

## **Cookie Policy**

**(Last updated: August 1st, 2019)**

**Limited Liability Company “Reland Activ S.R.L.”** (together with our affiliates, “Boosteroid”, “we”, “our” or “us”), duly incorporated under the laws of Romania, located at Sat Peretu, Comuna Peretu, Judet Teleorman, Romania, registration number: 31715471, that operates Boosteroid website, services and applications uses cookies. Here is our Cookie Policy. It is related to your privacy, so please, read it carefully.

Most of the websites/apps place small pieces of data on your device when you visit them. These small files are called cookies. We also use cookies to ensure that we give you the best experience on our website/apps.

### **What’re cookies?**

Cookies are small text files generated by your browser when you visit our website/apps and placed by us on your device. These tiny pieces of data are then read by our website/apps each time you return to us. Cookies help us remember your device and how you interacted with our website/apps (for e.g. cookies remember your username and password so you don’t need to re-enter each time you come back).

### **What’s Boosteroid Cookie Policy**

Boosteroid Cookie Policy is the document where you can find detailed information about the cookies we use, how we use them, how you can control them through limiting or forbidding us to place cookies on your device.

According to the EU privacy laws, we must inform you that cookies are in use, how they are used and obtain consent before cookies can be used, while our Cookie Policy shall constitute a separate document. Our Cookie Policy complies with data protection laws of the EU, the US, Switzerland and includes internationally accepted data protection concepts.

### **What cookies do we use and what for?**

We use cookies to protect you and customize your experience on our website/apps. We use CSRF token and Session id. CSRF token is used to prevent an attacker from placing a link or creating a form on a malicious website that will make you do something like password change, transfer funds, writing a message, providing your email, etc. while staying logged in without even knowing about that. CSRF token is unique for each action on our website, it is valid only for one particular action, is hard to crack, time-sensitive and is generated by a cryptographically secure generator of pseudorandom numbers.

We use session id to get information about visitors of our website/apps. When you connect to us you provide your registration details. After the authentication is completed, the session id is assigned to you by our web-server. This id is stored in your

browser and is provided each time the user authentication is required. This cookie allows you to move from page to page within the site without having to sign in again on each page. You can also save your sign-in information so that you won't have to sign in each time you return to us.

**The cookie-related information is not used to identify you personally.**

### **What third-party cookies do we use?**

We use Google Analytics and Google Tag Manager. We need Google Analytics to understand how users behave on our website. These cookies apply Google Analytics functionality. Special cookies help us get the information on how long have you been visiting our website, on what website were you before coming to us and how often do you come back to our website. Cookies are used to identify you as a unique visitor of our website by assigning a unique identification number. All the collected data is anonymized.

### **How to manage cookies?**

There is a number of ways for you to control cookies on your device. Depending on the browser you use, you can change your browser settings so that the browser will not accept cookies or alert you when cookies are being sent. If you change your cookies settings, the further website navigation will still be possible, however, some functionality (for e.g. keeping you signed in when you go from one page to another) may not be available.

You can check the “help” or “settings” page of your browser to find out how to block cookies or change their settings. The procedure may vary from one browser to another.

You can delete cookie-files that are already on your device and set most browsers to prevent them from being placed. For example, if you use Google Chrome, you can go to Settings > Privacy and Security > Clear browsing data > Cookies and other site data > click on “Clear data”. When you delete cookies stored on your device, that does not mean that cookies will no longer be placed. You can delete cookies after each time you've been online. When you delete cookies in a particular browser on a particular device, it may not always mean that they will be automatically deleted on another device even if the devices or browsers are synced. If you want to get rid of all your cookies, you should delete them separately on each device and in each browser.
